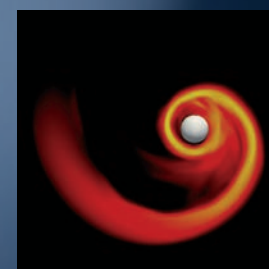

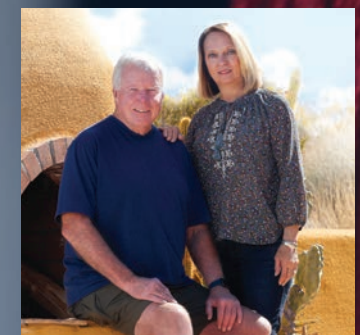

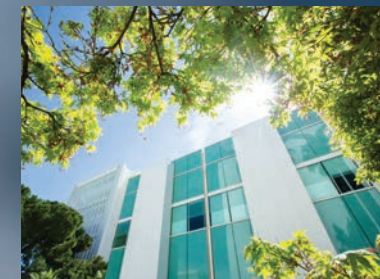

Ramadhan Ahmed's first introduction to Cal State Fullerton was in seventh grade, when he participated in the university's GEAR UP program. The program introduces junior high and high school students from underserved communities to higher education.

When he was ready to apply for college, Ramadhan turned to CSUF mentors to guide him through the process. "Cal State Fullerton has been an instrumental part of my life," he says. "When it was time to choose a college, the choice was clear."

At CSUF, Ramadhan worked side-by-side with outstanding faculty mentors and took advantage of such opportunities as the Bridges to Stem Cell Research program. Ramadhan scored in the 97th percentile on the MCAT and is currently a first-year medical student at Johns Hopkins University.

Kelly is one of 14 students who performed in the annual showcase for an audience of talent agents, managers, casting directors and producers. Students also participated in workshops with Broadway professionals and connected with CSUF alumni. For the first time in the program's history, every student received a call after the show.

Following graduation, Kelly landed a yearlong contract as a lead singer for Disney Cruise Line.

Cal State Fullerton empowered José “Pepe” Tapia, a first-generation student, on his path toward becoming an artificial intelligence professional. Through the Abrego Future Scholars program, he received academic and personal support to achieve his goals. “As I grew older, it was easier to understand and appreciate the value of a college degree,” he shares.

Pepe participated in ASSURE-US, a \$1.5 million National Science Foundation-funded grant program to boost the number of Hispanic students in STEM careers. He was selected for the California State University Edison STEM-NET Student Research Fellowship and was awarded an Amazon Web Services Artificial Intelligence and Machine Learning Scholarship.

Some of Pepe’s research projects included developing an AI coach for video games and developing a low-cost recording software device to stream live sports.

When Jacquelyn George transferred to Cal State Fullerton, she was searching for opportunities to get involved. She found a perfect fit in Titan Capital Management, a student-run investment program that provides hands-on experience in security analysis and portfolio management. Working with approximately \$3 million in assets, students decide when and where to invest, and the profits they earn support university scholarships and programs.

Jacquelyn became a member of the 2023 Titan Capital Management team that advanced to the global Chartered Financial Analyst Institute Research Challenge. The team is ranked one of the top six in the world among 1,000 teams.

She currently works as an investment analyst at Canterbury Consulting, where she interned during her senior year. Jacquelyn's long-term goal is to become an investment consultant.

Raising \$270 Million

OUR CAMPAIGN SUCCESS STORY

To elevate the potential of its students, Cal State Fullerton publicly launched its first-ever comprehensive philanthropic campaign in March 2020. With declining state funding, a significant student population and aging campus infrastructure, “It Takes a Titan: The Campaign for Cal State Fullerton” was an opportunity for the Titan community to ensure that students have the tools they need to succeed in a diverse workforce and rapidly changing global economy. The campaign invested in projects that enhance academic innovation, empower students, transform campus structures and enrich the greater community.

By the campaign’s close in December 2022, Cal State Fullerton raised more than \$270 million — surpassing its initial \$175 million goal and making it the third largest completed campaign in the history of the California State University system.

“When I think about the success of this campaign, the first thing that comes to mind is that the culture of philanthropy is alive and well at Cal State Fullerton,” said Greg Saks, vice president for university advancement. “The generosity of our donors knows no bounds.”

Following the success of its “It Takes a Titan” campaign, Cal State Fullerton finished the 2022-23 fiscal year with \$35,044,716 in gifts and gift commitments. This achievement marks the fourth consecutive year the university has raised more than \$31 million.

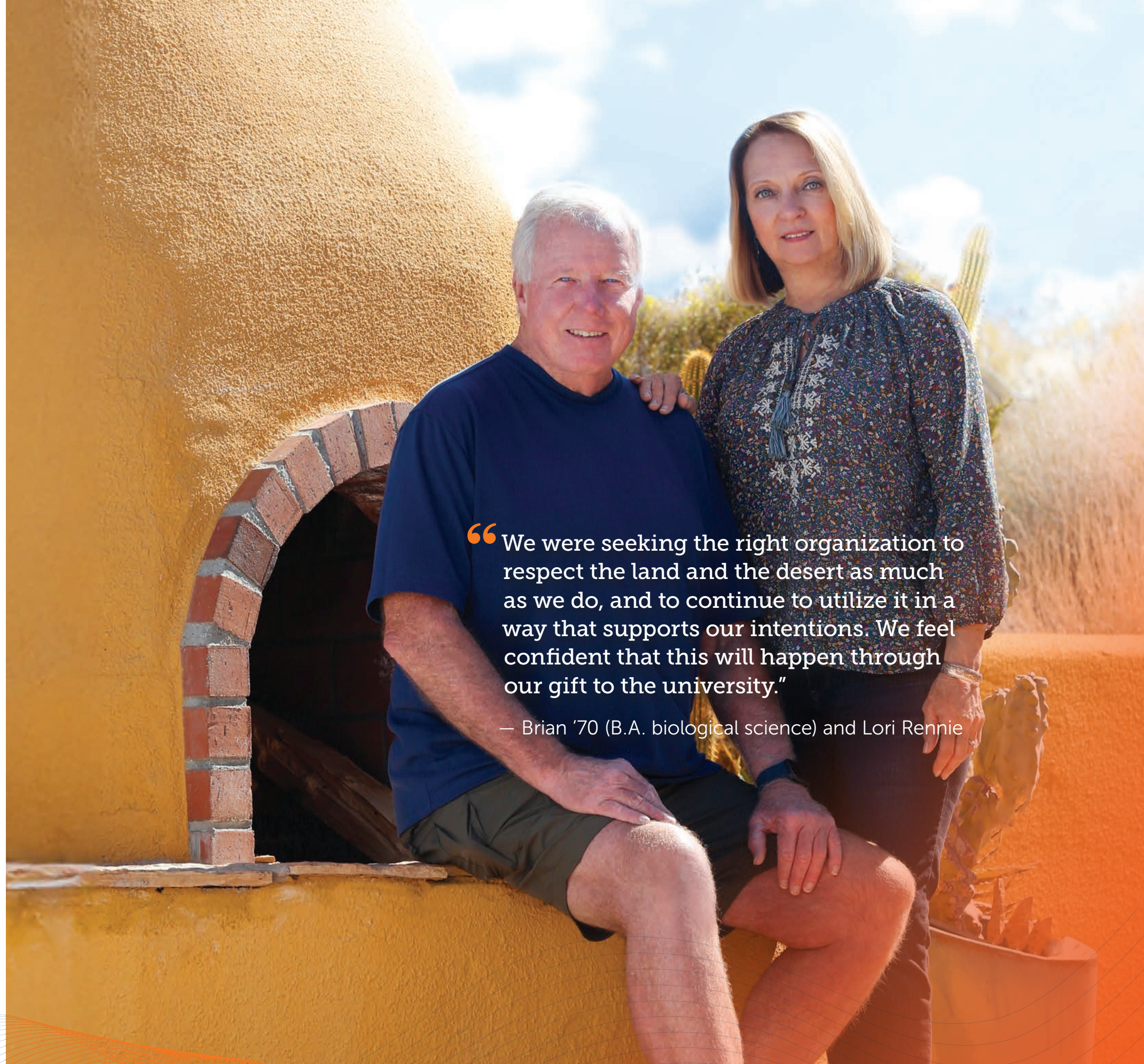
Biological science alumnus Brian Rennie is an expert-level rock and mountain climber with a passion for the natural world. He has reached the summit of the Matterhorn in the Alps, Mont Blanc in Europe, Aconcagua in Argentina and El Capitan in Yosemite National Park.

Together with his wife, Lori, the couple has pledged a planned gift valued at \$4 million to Cal State Fullerton, which includes their property in Joshua Tree, Southern California. Their gift will support desert science studies, conservation and climate change research, faculty and student travel, and fellowships.

"Having climbed some of the world's most significant mountains and being in these remote places, makes you understand how insignificant we are as individuals but how great our impact is as a society," says Brian.

"We were seeking the right organization to respect the land and the desert as much as we do, and to continue to utilize it in a way that supports our intentions. We feel confident that this will happen through our gift to the university."
